He spoke about his involvement with RI Reconnect and prison programs, emphasizing his belief in education systems that empower students to learn and thrive.

Chair Reyes reflected on his own academic struggles, noting that while he was not initially a strong student, teachers and social workers recognized his potential. Their belief in him inspired him to pursue higher education, serve on a school committee, and ultimately become its chair. He credited a social worker for making a significant difference in his life.

As the first person of color appointed as Chair of the Pawtucket School Committee, Chair Reyes expressed his commitment to paving the way for future generations. He emphasized the importance of holding himself accountable, fostering collaboration, and creating opportunities for children.

He expressed gratitude to the Pawtucket community for embracing and believing in him, noting that the city has always supported him and provided a sense of belonging and healing. Proudly identifying Woodlawn as his home, Chair Reyes reaffirmed the importance of community and placing children's needs first.

3. Election of Deputy Chairperson

Chair Omar Reyes called for nominations for the Pawtucket School Committee Deputy Chairperson. Juan Pablo Berrera put forth Joanne Bonollo for Deputy Chairperson. Kimberly Grant seconded this.

Member Barerra highlighted Joanne's unwavering dedication and commitment to children. He emphasized her passion for education and noted that she is the longest-serving active member of the Pawtucket School Committee. Joanne's wealth of expertise and experience will continue to be invaluable assets to the committee.
